BACKGROUND & OBJECTIVES

In the past years, especially in 2002, 2006, 2013 and 2014, parts of the Danube River Basin District were being affected by very strong or extreme floods. These events caused significant human and economic damages in the affected countries and communities.

To actively protect the Danube Region from flood risk events, the DAREnet project and the EUSDR Priority Area on Environmental Risks jointly organise the 2nd Annual Practitioner Forum – Training Edition. This virtual event focuses on the exchange of knowledge, best practices and innovative solutions to address current and future challenges in the Danube Region. The event is divided in two parts:

Since 2011, the European Union Strategy for the Danube Region (EUSDR) addresses two opposing negative effects of climate change: water shortage and flood risk events. To achieve this, 14 countries in the Danube region collaborate, exchange knowledge and innovate.
